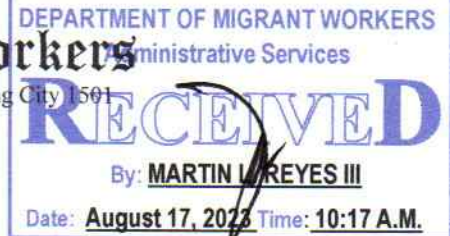

**DMW Direct Hires Processing**

The public is hereby warned of proliferating Facebook chats/groups intended for Direct Hire applicants giving inaccurate and misleading advice/information on the process to secure exemptions from the ban on direct hiring from the Department of Migrant Workers (DMW).

The Department is in receipt of reports that these groups have been scamming some applicants in the guise of giving unsolicited advice and even demanding certain amount of money in exchange of their services. The public is further informed that these groups were not created nor indorsed by the DMW.

The said groups are also reportedly offering services to the applicants by providing "assistance" to be able to secure clearance under the direct hiring facility of the Department. Said "assistance" are usually not in line with the legal way of the Direct Hire process.
